Notes for Contributors

The International Journal of Turkish Studies welcomes submissions of research articles, review essays, and archival reports relevant to the field of Turkish Studies. All submissions undergo an initial editorial review; those that pass this stage proceed to a double-blind peer review.

Scope

- Research articles offering innovative insights grounded in disciplinary and theoretical frameworks.
- Review articles critically engaging with recent literature, debates, or developments in the field.
- Advisor-recommended, unpublished portions of doctoral dissertations relevant to Turkish Studies.
- Archival reports whose publication could foster broader academic collaboration and knowledge sharing.

Technical or translated texts, as well as highly specialized material of limited relevance, will not be considered.

Manuscript Preparation

- Language: English.
- Length: Maximum 10,000 words, including notes and bibliography.
- Formatting: Microsoft Word, Times New Roman, 12-point font, double-spaced, one-inch margins, left-justified.
- Pagination: Number pages in the top-right corner.
- Paragraphs: No indent for the first paragraph of the article or of a new section; all other paragraphs indented 0.5 inches.
- Style Guide: Chicago Manual of Style (latest edition).
- Endnotes: Use endnotes (not footnotes) generated in Word; keep these to a minimum.

Tables, Figures, and Illustrations

Tables and figures must be cited in the text (e.g., "see table 1") and may be placed within the text or at the end of the manuscript. Photographs and maps may be submitted for editorial consideration.

Transliteration

Terms from languages using non-Roman alphabets must be fully transliterated with appropriate diacritical marks. For Ottoman Turkish, modern Turkish orthography should be used.

Originality

Manuscripts under consideration elsewhere or previously published will not be accepted. Upon publication, authors receive one copy of the volume in which their article appears. The journal does not provide offprints.

Book Reviews

The journal's book review editors solicit book reviews, though expressions of interest from potential reviewers of new or forthcoming academic titles are welcome.

Book reviews should be 800–1,200 words, Times New Roman, 12-point font, left-justified, with the first paragraph unindented and all subsequent paragraphs indented 0.5 inches. No extra lines between paragraphs. Reviews should not include footnotes; relevant information should be incorporated into the text.

Additional Information

The publisher reserves the right to copyedit and proofread manuscripts accepted for publication to conform to the Journal's style, which follows the Chicago Manual of Style. Substantial editing will be returned to the author for approval before publication. No rewriting will be permitted in the proof stage.

The copyright for all material published will be assigned to the International Journal of Turkish Studies.

The International Journal of Turkish Studies is published annually in the Fall and combines two issues in one volume. Some issues are also published separately by the Karpat Center for Turkish Studies at the University of Wisconsin–Madison (USA) as part of its book series.
